MANUSCRIPTS

The *Journal of Agricultural and Environmental Ethics* requires submitted papers to be accompanied by an electronic file (floppy diskette or e-mail attachment) produced using a software program such as Word Perfect or Word. All submissions should be made directly to the editor-in-chief, and should be addressed as follows:

We prefer that submissions be sent as an e-mail attachment to <rhaynes@phil.ufl.edu>.

Submissions should include an abstract, not to exceed 250 words, and a set of key words. Also include the full address for correspondence, including phone, fax, and e-mail address.

All manuscripts with publication potential will be blind reviewed by at least two referees in the author's field of specialization or in related disciplines. Reviewers' comments may be shown to the author, but the identity of their source will not be revealed.

The editor will accept unsolicited book reviews, short discussion pieces of previously published material, and reports about relevant projects, literature reviews, and annotated bibliographies. Announcements will be inserted on a space available basis.

FIGURES AND TABLES

Each figure and table should be mentioned in the text with an indication as to where it should be inserted into the text and should be numbered consecutively using Arabic numerals in the order of appearance. On the reverse side of each figure, write in pencil the name of the (first) author and the figure number. Figures and tables should be placed at the end of the typescript following the Reference section.

SECTION HEADINGS

Major headings should be in upper case, no bold, and centered. Subheadings should be in italics and aligned to the left.

ENDNOTES AND REFERENCES

Please use footnotes only, except in tables (see below). Be sure you do not mix footnote text and Bibliographic information. Bibliographic information should be listed in a separate *Reference* section (see REFERENCE section for more information). Footnotes should be indicated by consecutive superscript numbers. In tables, footnotes are preferable to long explanatory material in either the heading or the body of the table. Such explanatory footnotes, identified by superscript letters, should be placed immediately below the table. The first line of each endnote should be flush with the left margin. Subsequent lines should be indented .25 from the left and justified to the right. No space between notes. Numerals should be in normal position.

CROSS-REFERENCING AND CITATIONS

Do not cross-reference the page numbers of your paper. Cross references should refer to:

- section number of a heading
- the number of a displayed equation
- the number of a table
- the number of a figure
- the number of an enunciation
- the name / year of a reference entry

In the text, a reference already identified by the author should be followed by the date of the reference in parenthesis and the page number(s) where appropriate, e.g.: Winograd (1986: 204). Otherwise, the reference should be enclosed within parentheses including the name of the author followed by the date and page numbers, e.g.: (Winograd, 1986; Flores *et al.*, 1988). Use “*et al.*” if there are more than two authors. If there are two authors, list them both, e.g.: (Smith and Graber, 1994). In the event that the author has had two or more works published during the same

year, the citation and the reference should contain a lower case letter like a and b after the date to distinguish the works.

REFERENCES

References to books, journal papers, articles in collections and conference or workshop proceedings, and technical reports should be collected in a list at the end of the paper and listed in alphabetical order. If there are several authors, list them all, using the following form:

Smith, R. G. and P. L. Tonney
Healy, J. P., R. L. Smith, and T. Lerkert

References to books should include the author's name; date of publication in parentheses, title in full in italics; place of publication, publisher; page numbers. For example:

Sartre, J.-P. (1948), *Existentialism and Humanism*, London: Methuen, pp. 34-38.

References to essays in an edited collection should include the author's name; date of publication in parentheses; title of essay; editor's name; title of volume in italics; place of publication, publishers; first and last page numbers. For example:

Chisholm, R. M. (1966), "Freedom and Action," in K. Lehrer (ed.), *Freedom and Determinism*, New York: Random House, pp. 11-44.

References to essays in conference proceedings should include the author's name; date of publication in parentheses; title of essay; editor's name (if any); title of proceedings in italics; place of conference; publisher and/or organization from whom proceedings can be obtained; first and last page numbers. For example:

Lehrer, K. (1990), "Metamental Ascent: Beyond Belief and Desire," *Proceedings and Addresses of the American Philosophical Association* 63(3), pp. 19-30.

References to articles in periodicals should include the author's name; date of publication in parentheses; title of article; full title of periodical in italics; volume; numbers where appropriate; first and last page numbers. For example:

Gilbert, M. (1997), "Group Wrongs and Guilt Feelings," *The Journal of Ethics* 1(1), pp. 65-84.

References to technical reports or doctoral dissertations should include the authors name; date of publication in parentheses; title in italics; identifying number or description, department, institution, and location of institution. For example:

Branquinho, J. (1992), *Direct References, Cognitive Significance, and Fregean Sense*, PhD dissertation, Oxford.

When citing personal communications, list name or person; date in parenthesis, and address where communicator can be reached.

Reference to web sites should include the date accessed.

OFFPRINTS

Twenty-five offprints of each article will be provided free of charge. Additional off-prints can be ordered when proofs are returned to the publisher.

PAGE CHARGES AND COLOR ILLUSTRATIONS

No page charges are levied on authors or their institutions. Color illustrations are published at the author's expense only.

COPYRIGHT

Copyrights will be established in the name of Kluwer Academic Publishers

PERMISSIONS

It is the responsibility of the author to obtain written permission for a quotation from unpublished material, or for all quotations in excess of 250 words in one extract or 500 words in total from any work still in copyright, and for the reprinting of illustrations or tables or poems from unpublished or copyright material.

MORE INFORMATION ABOUT SUBMITTING PAPERS

In producing your paper, the author should use the following style notes:

Spacing: text lines should be six and one-half inches in length and justified. No spacing between paragraphs. The first line of each paragraph should be indented .25 inches. There should be a space before each section heading, and one following. A single space should follow punctuation marks, including periods. Do not use double spaces after periods. Do not use tabs for paragraph indentations.

When listing a series, use a comma before the conjunction preceding the final item in the series (John, Bill, and Mary). When using relative pronouns, use "that" to introduce a restrictive clause and "which" a nonrestrictive clause (e.g., The book that you gave me is here on the shelf. The book that you gave me, which I am still reading, is here on the shelf.) Use double quotation

marks except quotes within quotes. Place commas and periods inside of quotation marks, colons outside.

Use American English spelling throughout.

TECHNICAL APPENDICES

Supplementary technical material (e.g., mathematical proofs or descriptions of experimental procedures) should be collected in an Appendix that comes after the Notes and Reference sections.
