#### Nomination for the election of the new Executive Committee

In the December issue (vol.7 no.4) of EurSafe News the procedure for the

election of the new Executive Committee was presented along with a call for candidates. In line with Article 8 of the statutes the current Executive Committee nominates candidates for the election. This nomination is presented below. Other candidates can be nominated on the proposal of at least ten members of the society. Such nominations shall be given to the EurSafe President and the **deadline is Friday 23 June at 19.00.**

### Article 8 of the statutes

1. The Executive Committee shall consist of at least four (4) persons. Appointments shall be made by the General Meeting from among the members. The number of Executive Committee members shall be determined by the General Meeting. In the event of a vacancy, the Executive Committee may make a nomination, without prejudice to the authority of the General Meeting to appoint someone else.
2. Candidates for the Executive Committee may be nominated by the Executive Committee, as well as on the proposal of at least ten ordinary members.

**Kate Millar.** Kate is the director of the Centre for Applied Bioethics of Nottingham University, UK.

**Helena Röcklinsberg.** Helena is a lecturer of Theological Ethics at Lund University, Sweden.

**Mariachiara Tallacchini.** Mariachiara is a professor of Philosophy of Law at the Law Faculty of the Università Cattolica del Sacro Cuore – Sede di Piacenza, Italy. She teaches Bioethics at the Faculty of Biotechnology of the State University of Milan, and Science Technology and the Law at the Faculty of Philosophy of the University San Raffaele of Milan.

## Current Affairs

### ScanBalt: A bio-region in need of ethical assistance

No cries for help have been emitted. Nevertheless, assistance may be needed – assistance, that is, regarding how to identify and face up to ethical challenges relating to the development of biotechnology: Presenting itself as "Europe's first metaregion" the ScanBalt BioRegion has recently published a report on its activities and future plans for biotech innovation in the northern parts of Europe. The 26 pages report does not contain any reference to ethical challenges related to such efforts.

ScanBalt is an umbrella organization – a network of regional networks – covering 11 countries: Denmark, Estonia, Finland, Iceland, Latvia, Lithuania, Norway, Poland, Sweden, the northern parts of Germany and north-western Russia. Members come from universities, companies, development agencies, tech transfer organizations, hospitals and public authorities. In the report, the organization professes to be creating a knowledge-based bio-economy, to be assisting in reaching the goals set by the Lisbon agenda that the EU should become the most competitive knowledge-based economy in the world, and to be "acting as a tool to realize the ambitions of the EU strategy for life science and biotechnology" and, thus, to contribute to enabling the EU to compete successfully with the USA and Asia.

The stress on economic aspects, innovation and competition is repeated in the vision published together with the strategy for 2006-2008: "ScanBalt will promote

knowledge formation, education, research, technology transfer, innovation and economic development within life sciences in order to meet meta-regional needs and increase competitiveness. This will be in accordance with ScanBalt values. ScanBalt will be a forum for discussions of the impact of life sciences on society. ScanBalt will act as a platform and an umbrella for activities within life sciences." Concerning the values of ScanBalt it is stated that: "ScanBalt believes that the life sciences have a major potential to contribute positively to health, welfare and prosperity. The exploitation of life sciences and the promotion of growth must be conducted in tandem with a dialogue between science and society. ScanBalt will promote such a dialogue." Sustainable development is referred to as "an overarching objective", followed by the clarification: "Thus, the development and application of life sciences must take place in a way which is healthy to citizens and the environment and is consistent with common fundamental values and ethical principles. The development of ScanBalt BioRegion requires that these values are respected and that all involved parties will benefit while working together towards the same goals."

Beyond the statements on vision and values only one reference is made to ethics – in a listing of topics relating to a network on regenerative medicine. There is no specification concerning the aim of facilitating dialogue; and neither in the presentation of networks nor in the listing of selected articles and presentations does the report mention any ethical challenges. Correspondingly, no conflicts, whether relating to values or conflicting social interests, are being pointed to.

ScanBalt network topics include agrobiotech, clinical research, environmental biotechnology, informational biology, intellectual property and bio-entrepreneurship, marine biotechnology, molecular diagnostics, process analytical technology, regenerative medicine and stem cell research.

One of the aims of ScanBalt is to attract funding for its members. According to the report, ScanBalt has facilitated the raising of approximately 4 million Euros for its mem-

bers since 2002. Funding for the organization has been supplied by Nordic and European public purses, among these the Nordic Innovation Centre, Nordforsk and the sixth EU research framework programme.

The organization is committed to the triple-helix credo of furthering cooperation between universities, governments and industry. 14 universities are among the founding members,. Six of these universities are Swedish.

## New Website

### Farm subsidies

Danish authorities paid EUR 1.3 billion of farm subsidies to more than 70,649 recipients in 2005. There was a significant increase in the number of recipients compared to former years. Some 17,290 'first time' recipients were paid a total of DKK 440.645.234 or just less than 5 percent of all farm subsidies in 2005.

Farmsubsidy.org describes itself as "a collaborative project bringing together journalists and activists from more than ten European countries". The purpose of the project and the website is to publish data about farm subsidy payments, data obtained through freedom of information requests.

Farmsubsidies.org has strong links to the journalistic trend of Investigative Journalism and its branch called Analytical Reporting in

particular.

"Farm subsidies under the European Union's Common Agricultural Policy (CAP) amount to approximately EUR 43.5 billion a year, just over 40% of the European Union's annual budget, or an average of just under EUR 100 a year for each EU citizen. We believe that the people who are paying for this policy have a right to know where the money goes", writes one of the founders, the Danish journalist Niels Mulvad.

Mid-June there were data from ten European countries: Belgium, Czech Republic, Denmark, Estonia, Netherlands, Portugal, Slovenia, Spain, Sweden and the UK. For five countries access to data were denied: Austria, Finland, Germany, Greece and Poland, while for the rest of the EU countries the lack of data probably is due to lack of activists and journalists interested in the topic.

## Research Funding

### EU emphasis on agricultural research

Joseph Pröll, Austria's Agriculture Minister and President of the EU Agriculture Council, said there was a clear mandate for common EU agricultural research in the EU, following an informal meeting of EU agriculture ministers in Krems on 28-30 May. 'We have tackled issues important to the future at this informal meeting,' he said.

'One result of our talks was the realisation that there is insufficient coordination and cooperation between Member States in research and development. We need a common European research vision in the agriculture sector,' he said.

'The WTO negotiations, which will come to a head again next week, will clearly pose

challenges we must overcome. Politicians can give support by providing appropriate conditions, but it is above all the farmers themselves who will have to act,' said Mr Pröll.

In order to deliver these 'appropriate conditions', the ministers felt more research would be essential to equip farmers for the additional pressure that lies ahead. The Sixth Framework Programme (FP6) currently devotes the Food Quality and Safety thematic area to research 'from farm to fork'. Under FP7, this will be expanded to 'Food, agriculture and biotechnology', one of nine thematic areas. The informal meeting gave ministers the opportunity to speak freely, and they identified four key areas with 'deficits', of which Research and Development was the first.
